In view of the establishment of the The Charutar Vidya Mandal (CVM) University, Opp. Shastri Maidan, Beside BVM College, Vallabh Vidyanagar, Distt. Anand, Gujarat by State Act, the name of the University has been included in the list maintained by the UGC on its website www.ugc.ac.in.

This may be done only after creation of required academic and physical infrastructure facilities, including library, laboratories and appointment of teaching and supporting staff as per the norms and standards laid down by the UGC and Statutory Council(s) concerned.

The University is now requested to submit detailed information in the enclosed format (Annexure-I)(soft copy as well as hard copy) along with supporting documents duly attested by the Registrar of the University within a period of 3 months from the receipt of this letter. The following Act of the Gujarat Legislature, having been assented to by the Governor on the 19th August, 2019 is hereby published for general information.

GUJARAT ACT NO. 20 OF 2019.

(First published, after having received the assent of the Governor, in the "Gujarat Government Gazette", on the 20th August, 2019).

AN ACT

further to amend the Gujarat Private Universities Act, 2009.

WHEREAS the Charutar Vidya Mandal, Vallabh Vidyanagar and Samata Lok Sansthan, Vadodara have applied to the State Government under the provisions of the Gujarat Private Universities Act, 2009 to establish Private Universities in the State;

Guj. 8 of 2009. AND WHEREAS the said applications have been scrutinised by the Scrutiny Committee and on report of the Scrutiny Committee, the State Government has issued the Letter of Intent to the respective sponsoring body for establishment of the Private University;

AND WHEREAS the State Government is satisfied that the sponsoring bodies have complied with the conditions of Letter of Intent as provided in section 10 of the said Act and have also established the Endowment Fund as per the Letter of Intent;

NOW, THEREFORE, the Government of Gujarat, in accordance with the provisions of section 10 of the said Act, includes the institutions specified in column 2 of the Schedule as a Private University, by the name and location of the aforesaid sponsoring bodies as specified in column 4 of the said Schedule.

It is hereby enacted in the Seventieth Year of the Republic of India as follows:-

Short title and commencement.

- 1. (1) This Act may be called the Gujarat Private Universities (Second Amendment) Act, 2019.
- (2) It shall come into force on such date as the State Government may, by notification in the Official Gazette, appoint.
